Beloved of Christ in the Nebraska Synod,

Over the last few months, an organization calling itself the Lutheran Congregational Support Network (LCSN) has created a host of resources which they claim are intended to support congregations in their relationship with synods and the churchwide organization of the Evangelical Lutheran Church in America (ELCA). I'm writing to you today to address their core questions, correct some misinformation, and encourage you to contact the Nebraska Synod office if you have further questions that are not addressed in this letter.

The LCSN website identifies three core questions for ELCA congregations:

1. *Who controls your governing documents?*
2. *Does your congregation have sole control over its property?*
3. *Is your pastor free to say what she/he believes?*

There is nothing wrong with asking these questions. I'm happy to give you my answers here.

1. Who controls your governing documents?

From the earliest days of the ELCA, our church has been interdependent in nature. The Model Constitution for Congregations was included in the original governing documents of the ELCA, and ELCA congregations have always been required to adopt the Model Constitution whenever they update their local constitution. However, aside from those provisions required by the Model Constitution, congregations can structure their governing documents in any way they please so long as they don't contradict the Model Constitution. In the Nebraska Synod, we have a Constitutional Review Team who work with congregations to help them amend and adopt governing documents which reflect the congregation's context, needs, and resources and our shared commitment to interdependence across the ELCA. The aim is consistency, not control.

2. Does your congregation have sole control over its property?

The short answer to this question is, "Yes!" A fuller answer is, "Yes - assuming your congregation is acting in accordance with your constitution." There are constitutional provisions under which the Synod Council (not the bishop or the synod office) may act to place a congregation under synod administration, but those provisions only address situations in which a congregation is either unable to govern itself or is blatantly violating its constitution. Some hypothetical examples might be 1) a congregation that can no longer maintain its building or ministry; 2) congregations facing legal action due to misconduct of ministers, staff, or volunteers; 3) congregations in deep, prolonged internal conflict. Synod administration has never been enacted in the Nebraska Synod, and across the ELCA it has been enacted in only the most extreme instances. Administration can also be appealed. In all but the most extreme circumstances, ELCA congregations control their property. My role as bishop is to help congregations manage their property and ministry in accordance with their governing documents, for the sake of consistency, not control.

3. Is your pastor free to say what she/he believes?

ELCA rostered ministers (deacons and pastors) are not completely free to say whatever they believe. Our ordination vows are clear: rostered ministers of the ELCA must preach and teach in accordance with Holy Scripture, the Nicene, Athanasian, and Apostles' Creeds, and the Lutheran Confessions. Sermons, public statements, or other messages which violate our common understanding of Scripture, creeds and confessions can be cause for disciplinary action. An ELCA rostered minister is not free to pray, preach, or teach in the name of Ba'al, Zeus, or Osiris, for example. However, Lutherans are a people of faith who value bold questions and courageous discourse, particularly on those issues which are neither commanded nor forbidden by Scripture, creed, and confession. We encourage our rostered ministers to be forthright and honest. The ELCA has adopted social statements, messages, and policy resolutions over time which inform and guide our public witness as a community of moral deliberation, but their status is one of support and discernment, not enforced subscription. Neither I nor any other bishop of the ELCA are called to be the thought police of the synod's rostered ministers. The church is united by the Holy Spirit, not by the imposition of one political, sociological, or ecclesiastical viewpoint.

So, having answered these questions, I'd like to ask a few of my own. What is the Lutheran Congregational Support Network? Who are the persons making these accusations about the ELCA? The LCSN claims they have analyzed ELCA documents, interviewed pastors, and sought extensive legal counsel regarding the ELCA's shift. Who are the legal experts providing counsel to this network? The assertions presented by the LCSN are riddled with inaccuracies and misinterpretations, and also sorely lacking in cited sources or acknowledgment of authorship. Why should congregations believe such unsubstantiated and anonymous allegations, particularly when the concerns raised by the LCSN can easily be addressed by a call to the synod office?

Having been an ELCA pastor for almost 22 years, and an actively engaged member of this church for over 30 years, I am well aware that we are a denomination that is still learning how to live well together. In the 36 years since the merger that created the ELCA, we have changed in many ways, but there are also lingering issues that continue to plague us. One of them is deep suspicion of bishops, the presiding bishop, and the churchwide organization. I can assure you that bishops can and do make mistakes. Living in relationship means living with people who will disappoint, confound, and wound us. However, the true mark of faithful Christian community is confessing our sins, owning our mistakes, and being people of forgiveness and integrity. I don't see integrity in the anonymous accusations levied by the LCSN. I see a determined effort to create suspicion and division through misinterpretation and misinformation.

The prophet Zechariah reminded his listeners that God intends for us to be a people of truth and accountability: "these are the things that you shall do: speak the truth to one another, render in your gates judgments that are true and make for peace..." (Zechariah 8:16) Friends, I am more than happy to discuss any concerns about the ELCA with anyone at any time, and I pledge to you that I will be as forthright and honest as I can be about the future of our church as I see it. Let's put our trust in each other as we live together in this church God has entrusted to us.

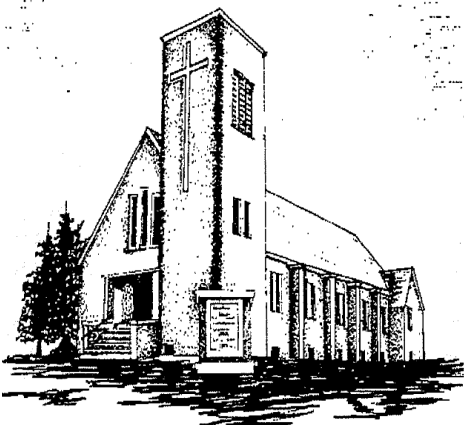
